

TERMS AND CONDITIONS

- MOQ approximately 30.000 pieces for a production run.
- Remnants of unique ingredients which are special purchased for customer are invoiced to the customer immediately after production. It is also possible to put the remnants ingredients on stock under contractual purchase obligations.
- The customer is responsible for designing the packaging. Van
 Vliet B.V. makes the product specification.
- We aim to maintain a delivery time of 6 weeks. This also depends on delivery of the raw materials and approval of the final product from the customer.
- In the case of printed packaging materials, the customer supplies the foil, boxes and labels. Take into account the loss percentage of 5%.
- Van Vliet B.V. can provide blank foil and boxes (standard sizes that are commercially available).
- We charge the customer € 1.000,-- for testing the created bar.
- Odd sizes are negotiable. The mold cost for creating the odd sizes are charged to the customer.
- Payment before shipment.
